10:15 am – Call to Order

10:20 am - 2019 and 2020 Annual Meeting Minutes

The 2019 Annual Company Meeting minutes were not sent out in 2020. They were included with this meeting for approval and reviewed in advance of the meeting. No additional chances suggested.

Motion to approve was made by Captain Stokes. Lt. Hayward second. Approved by all without objection.

The 2020 Annual Company Meeting minutes were sent out for review and approval in advance of the meeting. No additional changes suggested.

10:25 am - New Members

We have one new member, Bob Lili, who was recommended for approval on a motion from the floor. Captain Stokes motioned to make Bob Lili a full member. Lt. Hayward seconded. Approved unanimously.

There was a question raised if Nathaniel Richmond was a full voting member. After review of the 2020 meeting minutes, it is confirmed that he was voted in as a voting member.

10:30 am - Paymaster's Report

2020 Cash flow was positive despite no events. The Company remains in good finances. Our current balance is **\$25,369.07**.

Note on Musical Expenses:

2020 Music budget was \$700. Actual expenses were:

\$415 as final payment on new snare drum (March)* \$35 bank fee for cancelled check (March) \$20 for drum hooks.

Actual Expense Total = \$470.

Not Spent (difference) = +\$230 (this is a *surplus*, not a deficit.)

*Note: The actual check was for \$865. However, it included an extra \$450 that was a replacement for a Dec. 2019 check which had been lost. This extra \$450 was a legitimate 2019 expense and recorded in that year. The \$920 figure noted on slides shall be revised in the minutes. A reduction of the expense shall be by \$450, and the actual balance matches the information provided by the Music Master at \$470.

10:45 am - Armorer's Report

No season in 2020. Minor events: Memorial Day and Collings Foundation.

Black powder price has increased but budget can stay the same. Not a huge cost.

Potential new muster location available for 2021 (Collings Foundation to space out)

10:50 am - Quartermaster Report

Need a volunteer to fill the vacant position. Ann Gibson volunteered to take on the clothing half of the position, contingent on storage of clothing elsewhere. Need a co-quartermaster to take on the management of stuff (tents/tables, poles, chairs, etc.).

Can review the budget once we know who is filling the roles.

10:55 am – Music Master's Report

Despite the pandemic, still holding weekly Fife and Drum group practices, but Zoom is not an ideal music platform. Also providing individualized fife lessons, and these have gone extremely well. Looking forward to playing together again in person.

11:00 am - Ensign's Report

Will investigate guidon repair or replacement for 2021

11:10 am - Captain's Report

COVID-19 Safety Discussion:

There was a discussion surrounding the pandemic and if members felt comfortable participating in 2021. The general consensus was that we would review events as they come in and make determinations appropriately. There are changes happening everyday which make it

impossible to determine what position we will be in to participate in four months. Will review again with membership in February.

2021 proposed Events (generally the same as 2020 with addition of tentative Collings Foundation event in October):

Scholarship award amount proposed increase to \$1,000.00 was approved for 2020

Required minimum participation for scholarship consideration was altered to: Participation in at least 4 different events per year (2 paid) for 3 years.

Due date for applications was changed to 2nd Saturday after the Trail March

11:30 am – 2021 Dues

Discussion was had on the continued need to carry Membership dues for the Company. It was brief.

There was a motion to suspend the 2020 dues for all members based on the healthy state of the Company finances and that a suspension of dues would not present a hardship to the Company. The motion was voted and carried but dues will remain in the Company Charter.

11:35 am – Trailer Committee

A report was given on the status of a trailer purchase. The Stokes vehicle is gone and so we need to purchase or rent a trailer to carry items to encampments. Karen Walrath motioned to approve an up to \$3,500 expenditure as described on the slide for a trailer. Said approval would be a \$3,500 line item on the 2021 budget. Rob Caponi second. Approved unanimously by all in attendance.
